There will be NO RAIN date for this event. Fee covers space for all days, used or not.

Your space is NOT reserved until we received your payment. Personal checks are not accepted.

Verbal Agreement and deals are not acceptable and will not be honored.

Group rates and packages are NOT available.

If available, vendors requesting space the day of event will be charged the late fee of \$50.00; Spaces are sold on a first con first serve bases.

Tables will be available only if reserved and will be delivered to your location by attendants, when you arrive.

Food is only to be sold in the food court area. Retail vendors may not sell food, beverages or any snack items.

The sale of pirated, "boot-legged", copied or reproduced merchandise, CDs, VHSs, or DVDs from any vendor is prohibited by law. The sale of these items will not be allowed.

Music vendors may not play music with extremely loud volumes, as decided by AACA staff. Complaints from neighboring vendor may result in immediate dismissal.

The AACA reserves the right to ask any vendor to leave the festival, for violations or any other reason deemed necessary. Please be aware that no refund will be given if you are asked to leave.

ALL VENDORS ARE EXPECTED TO LEAVE BOOTH AREA(S) CLEAN AND WITHOUT DEBRIS OR TRASH.
